

# JPEG XS Patent Portfolio License OVERVIEW OF TERMS

This document is for information purposes only. All terms and definitions included in this document are detailed in the JPEG XS PPL Agreement, which constitutes the only definitive and reliable statement regarding license terms and conditions.





### **Objectives**

JPEG XS is the new lightweight low latency JPEG codec.

The goal of the JPEG XS Patent Pool is to offer the essential JPEG XS patents of the JPEG XS Licensors (Fraunhofer and intoPIX) under a single JPEG XS Patent Portfolio License (JPEG XS PPL) so that manufacturers, developers, and service providers can efficiently implement the JPEG XS Standard in their products or services on the basis of fair, reasonable and non-discriminatory (FRAND) licensing.

The royalty models have been developed to cater for the use of JPEG XS technology across different business models and use cases.

The administrator of the JPEG XS Patent Pool is UK-based Vectis IP.





### Coverage

The JPEG XS PPL grants a license under all essential patents owned and licensable, presently or in the future, by Licensors or their Affiliates for defined products and services that conform to the ISO/IEC 21122 (JPEG XS) Standard in compliance with the Light, Main & High Profiles.

The following is presently covered by the JPEG XS PPL:

- Devices sold or Software provided by Licensee in the End User JPEG XS Market without time limitations that constrain the relevant End User's use of such products.
- Devices sold or Software provided by Licensee in the End User JPEG XS Market on a subscription basis with time limitations that constrain the relevant End User's use of such products.
- Time-limited services provided by Licensee for real-time processing of live or pre-recorded content, with the End User billed on a consumption basis.

No license or other authorization is provided under the JPEG XS PPL to sell or provide any products to the Service-Related JPEG XS Market.





### **Licensing Models**

As of 1 March 2022<sup>(\*)</sup>, the JPEG XS PPL provides for the following Royalty Models:

- Model 1: Pay Per Instance/Product Royalty Model (covering Permanent Products)
- Model 2: Pay Per Activation Royalty Model (covering Time-Limited Products)
- Model 3: Pay Per Use Royalty Model (covering Real-Time Content JPEG XS Services)
  <sup>(\*)</sup> Updated in March 2023

Terms of reference:

- An Instance is a single operation which consists of either encoding, decoding, editing, or analyzing one JPEG XS Stream at up to a maximum input or output frame rate of 60 fps.
- A Product is a ready-to-use End-Use solution (e.g., hardware device or software application) capable of encoding, decoding, editing, and/or analyzing one or more JPEG XS streams.
- An Activation is a time-limited (yearly, monthly, or weekly) subscription-based release of a Product.
- A JPEG XS Service provided by Licensee uses a functionality capable of encoding, decoding, editing, and/or analyzing one or more JPEG XS streams.

# JPEG XS PPL – Model 3 Pay Per Use Royalty Model

#### Notes:

- For Categories A to F, the royalty rate is per hour or per day of each Real-Time Content JPEG XS Service and based on resolution (576/720p/1080i/HD/4K/8K).
- The determination of whether License Fee per Hour or per Day is applicable depends on Licensee's Service Pricing Model (i.e. Licensee's consumption-based method of calculating the price of a JPEG XS Service available to an End User). If Licensee's Service Pricing Model for a Real-Time Content JPEG XS Service is on a daily (or longer) basis, the License Fee per Day shall be payable for each day (or part thereof) of each Real-Time Content JPEG XS Service.
- The royalty rate starts from Category A. Once the annual aggregated royalty amount achieves a category's upper threshold, a reduced royalty rate applies to the next category. Model 3 category volumes are not aggregated with Model 1 & 2 category volumes.





### **Additional License Terms**

- In Model 1 & 2, for Royalty Categories 1 to 5, Royalty License Fee is capped to the greater of (i) 2% percent of the Product Price, or (ii) 1.5 times the License Fee applicable to a 4K Instance of the Royalty Category such Product is subject to, if selling price is publicly disclosed.
- Licensee shall be entitled to discounted License Fees if it chooses to pre-commit a payment of a predetermined amount of annual aggregate royalties. Please refer to the PPL for full details of the Pre-Commitment Program.
- Irrespective of Royalty Model, an aggregate Annual License Fee Cap per company is available.
- Royalty statements are due on a quarterly basis.
- Licensee shall mark all Licensed Products with the Licensed Patent numbers and provide written notice throughout the distribution chain of the Licensed Products about the scope and limitations of the license under the JPEG XS patent pool.





### Term

- Current terms are valid up to December 31, 2025.
- Renewable for successive 5-year periods for the life of the Portfolio patents subject to reasonable changes of terms and conditions.
- License Fees will not increase by more than 20% at each 5-year term renewal.
